

Ever wonder what we discuss at FRN's IEP workshops? Here's some basic info that we discuss in detail at the workshops.

### Basic Parents' Rights in the IEP Process

- Right to receive a written copy of special education rights
- Right to have child assessed in suspected area(s) of need
- Parent must give written approval prior to assessment of child in suspected area of need
- Right to have the IEP meeting at a mutually agreeable time and place
- Right to bring others to the IEP meeting
- Right to audio record the IEP meeting (written notice must be given by parent)
- Right to have the meeting translated into their preferred language
- Right to be an active member of the IEP team including identifying child's strengths and areas of need
- Right to bring information from sources other than Education to the IEP table, but the information must indicate an educational need
- Right to actively participate in the creation of the IEP document with IEP team members
- Right to have their opinions listened to by IEP team members
- Right to review IEP document for an unspecified amount of time prior to signing the IEP document (or refusing to sign)
- Right to use alternative dispute resolution, mediation and/or the fair hearing process.

### **Changes in CA Immunization Exemptions Effective January 2016**

Governor Brown signed Senate Bill (SB) 277 on June 30, 2015. Effective January 2016, SB 277 will:

- No longer permit immunization exemptions based on personal beliefs for children in child care and public and private schools;
- Permit personal belief exemptions submitted before January 1, 2016 to remain valid until a pupil reaches kindergarten or 7th grade;
- Remove immunization requirements for:
- Students in home-based private schools
- Students enrolled in an independent study program who do not receive classroom-based instruction
- Access to special education and related services specified in an individualized education program

Students in the above categories will still need to provide immunization records to their schools before entry, and schools will still need to report to the California Department of Public Health (CDPH) the immunization status of all students at the existing checkpoints of child care, kindergarten and 7th grade;

 Allow medical and personal beliefs exemptions from any new immunization requirement initiated by CDPH for attendance at school or child care.

#### **Medical Exemption**

A licensed physician (MD or DO) who feels a vaccine is not indicated for a student because of medical reasons should submit to the school (via the patient's family as needed) a written statement documenting the medical exemption. The school will place a copy of the completed statement in the student's file.

# AB 564 Signed by Governor Brown

**Editor's Note:** This issue was brought to the attention of the CA legislature after a local parent contacted the State Council on Developmental Disabilities, North Valley Hills Office.

Under existing law, the Lanterman Developmental Disabilities Services Act, the State Department of Developmental Services is required to contract with regional centers to provide services and supports to individuals with developmental disabilities and their families. Existing law requires the Director of Developmental Services to establish, annually review, and adjust as needed, a schedule of parental fees to be paid by parents of children under 18 years of age who are receiving 24-hour out-of-home care services through a regional center or who are residents of a state hospital or on leave from the state hospital.

Existing law provides that all parental fees collected by or for regional centers are remitted to the State Treasury to be deposited in the Program Development Fund, a continuously appropriated fund.

This bill would, effective July 1, 2016, revise and recast those provisions by, among other things, calculating monthly parental fees based on a percentage of the parents' annual income and authorizing a credit of the equivalent of one day of the monthly parental fee for each day a child spends 6 or more consecutive hours in a 24-hour period on a home visit. The bill would prohibit a monthly parental fee from exceeding the maximum monthly cost of caring for a child or the cost of services provided, whichever is less. The bill would require, for parents of children placed in 24-hour out-of-home care prior to July 1, 2016, the monthly parental fee to be calculated at the time of the parents' annual fee recalculation, or within 60 days of a parental request for review by the department and receipt of the family's completed family financial statement. The bill would provide that the Program Development Fund is available upon appropriation by the Legislature and make other related and conforming changes.
