# **President Bush Signs IDEA Reauthorization**

In December of 2004 President George W. Bush signed the bill that reauthorized the Individuals with Disabilities Education Act (IDEA) which is the legislation that covers special education services, including the Individualized Education Program (IEP). The legislation is called the Individuals with Disabilities Education Improvement Act (IDEA 2004). Most of the changes to the bill go into effect on July 1, 2005.

As of this writing it is unknown when the Federal Regulations will be published. These regulations give directions to schools on how to follow the law. Additionally, it is unknown at this time how California will interpret the changes to IDEA. FRN staff will be attending workshops on the new legislation and all FRN's special education workshops will include up-to-the -minute information on IDEA 2004.

Some changes that were passed by Congress as part of IDEA 2004:

Short term objectives for meeting each child's measurable annual IEP goals will cease for most children. Only those children "who take alternative assessments aligned with alternate achievement standards" will still be obligated to have short term goals.

**Transition to Adult Services**. IDEA 2004 states that the IEP that is in effect on the child's 16<sup>th</sup> birthday must include appropriate measurable post-secondary goals for education, training, employment and independent living skills. This is a change from the current law in California that starts the transition process by the child's 14<sup>th</sup> birthday.

IEP team attendance and participation. A new section of IDEA 2004 authorizes IEP team members to be excused from attending the IEP meeting if their area is not being discussed. Written parental consent is required before members of the IEP team can be absent from the meeting. New provisions allow other ways to participate in meetings such as conference calls. Other provisions authorize combining reevaluation meetings and other IEP meetings and, in certain instances, changing the IEP without meeting. **Transfer between school districts.** When a child with disabilities moves between school districts during the school year, the new district must provide services comparable to those in the IEP and be in effect before the transfer. In a transfer *within the state*, the services must continue until the new district adopts the previous IEP or develops, adopts and implements a new one. If the transfer is to another state, the new school district must also continue to provide services comparable to those on the incoming student's IEP until the new district conducts an evaluation of the child (if necessary) and "develops a new IEP."

Learning Disability eligibility changes. IDEA 2004 defines "specific learning disability" as a disorder in one or more of the basic psychological processes involved in understanding or in using language, spoken or written, in which a disorder may manifest itself in the imperfect ability to listen, think, speak, read, write, spell, or do mathematical calculations.

**Statute of limitations.** For the first time the federal statute states that parents have a 2 year limit, from the time they knew o,f or should have known, that an IDEA 2004 violation occurred, in which to file an administrative due process complaint about any matter concerning the identification, evaluation, placement of provision of a free appropriate public education. The statute states that the two-year limitation will apply unless it is inconsistent with state law. We are waiting to see California's position on this.

There are changes to the Stay-put and Manifestation Determination Review provisions of IDEA 2004. The Dispute Resolution process has also been modified. As stated previously, the federal and state regulations will give us a clearer picture on how these changes will be implemented in California. Future FRN newsletters will address these issues.

## **Early Start Transition**

California's Early Start Program serves children ages birth to 36 months with developmental disabilities or who are at risk for developmental disabilities. The laws that cover these Early Start services are Part C of the Individuals with Disabilities Education Act and the Lanterman Act. As a child approaches his/her 3<sup>rd</sup> birthday, there is a process for transitioning the child from the Early Start Program. The law states that the Regional Center and the school districts must have a transition process in place that provides for a "smooth transition with no gaps in service." Here is the timeline for the transition process:

At 2 years, 6 months the child's Service Coordinator must:

- Notify the parent that transition will occur in the next 3 to 6 months.
- Notify the local education agency (school district) that there will be an Individualized Family Service Plan (IFSP) meeting to address transition steps before the child turns 2 yrs, 9 months.
- Within 30 days of notification of meeting, coordinate meeting date with parents and school district.

At 2 years, 9 months IFSP transition steps must include:

- Information to the parent about special education eligibility at age 3.
- Steps to prepare the toddler for changes in service delivery.
- Information about community resources.
- Projected date for the final review of the IFSP to review transition outcomes by age 3.

For a child whose first IFSP is held after age 2 years, 6 months, that IFSP must include transition information.

If there is any possibility that the child will qualify for special education services at age 3, a representative from the school district where the family resides should be participating in the transition process in order to ensure a smooth transition. If you have questions about your child's transition from the Early Start Program you should contact your service coordinator immediately.

# You Can Make a Difference in Our Lives Thoughts to a Professional from a Parent

I believe that as professionals who work with children with disabilities you can make a difference in our lives as parents of children with special needs. You cannot however, make THE difference. Therein lies the challenge of our partnership. Highlighted here are ten ways in which you can make an important difference.

One: You have the opportunity not to be frightened by our anger...to embrace it, to welcome it, and even to invite it on a good day. You have the opportunity not to be intimidated when we blow off steam. You have the opportunity not to personalize these angry, negative feelings. The great challenge for you is to give us the opportunity to fall apart once in awhile. You may be surprised by how quickly we recover when we are given the opportunity to feel our feelings in the community of experienced and caring professionals.

# Two: You have the opportunity to decrease our profound sense of loneliness. You have the

opportunity to break that silence and gently lead us into the sounds of compassion and respectful curiosity. So often we want to talk about "it", but few people appear to want us to talk. You often will be the ONE person who will say, "Tell me more... and then what happened...and how did that feel?"

Three: You have the opportunity to anticipate and normalize our feelings. You can prepare us for the challenges of birthdays and holidays. You can let us know that we will have wild mood swings and uncomfortable thoughts about "those parents" with normal children. Never underestimate the significance of your anticipation and acceptance of your feelings. It will comfort us during those long sleepless nights.

Four: You have the opportunity to help us re-enter the "world of normal families." Parents with special needs children never feel the same once they learn about their children's differences, especially when those differences are cognitive. We don't know how to squeeze back into the world despite the fact that we are in it. Going to a birthday party can be a major mountain to climb. You, as the professional, can create bridges back to that world.

Five: You have the opportunity to help us know our child. In the beginning, most of us know very little about the disability or special needs. We often can't even spell this new reality in our lives. You can model

for us how to say the words, how to tell others. You can take us into our children's lives.

Six: You have the opportunity to share books, pamphlets, and other resources. Take those books and articles out of your file cabinets and off the shelves and share them with parents who have no idea where to find the stories and facts about their children. It is very challenging to walk to the "disability" section of the bookstore or library. You can tentatively open those pages.

Seven: You have the opportunity to recognize and celebrate our victories. They are often too small for the "normal" population to appreciate. You know that strange sound "grunt" made by our child is truly a miracle. Only you know that a new movement is significant and indicates a renewed sense of hope. You can point out these grand milestones to us.

Eight: You have the opportunity to remind us how far we have come and how much we have accomplished. You, often more than our closest friends, know the details of our successes. Over and over you can highlight those changes and celebrate the growth.

Nine: You have the opportunity to allow us those moments when our souls fall into deep despair. We will at times feel that we cannot continue for another moment. We will at times feel that we don't want to continue for another moment. You can give us space to be in that dark place. It is one of the greatest "interventions" that you can provide.

Ten: If at times you can do some of these nine suggested activities, you will then have the opportunity to help us feel hope. We must feel hope if we are going to get to our next appointment, or to face the next birthday party, or to use the words "special needs".

Effective partnerships between parents and professionals require collaboration. Plopped right in the middle of that word you find the word "labor". Partnership is labor. It is hard work. You are the midwives helping us give birth to a new relationship. Let us begin!
