Lawsuit Affects Release of Student Data-- "Opt Out" Available

A recent lawsuit against the California Department of Education (CDE) is impacting all school districts across the state. We want to make you aware of this and provide you with the available **Objection to Disclosure form** and other important information regarding this case.

In April 2012, two organizations, the Morgan Hill Concerned Parents Association and the Concerned Parent Association, filed a lawsuit against the CDE alleging widespread, systemic non-compliance by local education agencies with special education laws.

As part of the lawsuit, CDE has been ordered by the US District Court to release all data it has collected on K-12 general education and special education students since January 1, 2008.

Deadline to turn in this form is APRIL 1, 2016.

IHSS Alert: IHSS parent providers of minor children

If you are told by the County that you cannot be a provider for your child unless you previously had a job, this is incorrect.

You can be the IHSS provider for your child if you are prevented from obtaining full-time employment right now because no other suitable provider is available. You can also be the IHSS provider for your child if you left full-time employment because no other suitable provider is available. However, state law and regulations do not require that you left full-time employment at a particular time or for a particular reason or even that you have ever been employed full-time at all. You can be the IHSS provider even if you have never worked. The only requirement is that you are prevented from obtaining full-time employment because of the care your child needs now.

According to state regulations, a parent can be an IHSS provider if "The parent has left full-time employment or is prevented from obtaining fulltime employment because no other suitable provider is available and the inability of the parent to perform supportive services may result in inappropriate placement or inadequate care." (Manual of Policies and Procedures (MPP) 30-763.451.) Full-time employment means 40 hours per week or more. (MPP 30-763.451(a).)





The following information was provided by San Joaquin County Public Health Services:

Kaitlyn's law

Kaitlyn's Law (VC 15620) Unattended Children in Vehicles: • No person may leave a child age 6 or younger in a vehicle (unless supervised by someone at least age 12) if the health or safety of the child is at risk, the engine is running, or the keys are in the ignition. The citation is a minimum \$100 fine.

Car Seat Law

Children must be properly buckled in a safety seat or booster, in the back seat of a vehicle, until they are at least 8 years old or 4 feet 9 inches tall. • If a child is not in a car seat, the driver or parent can get a citation with a minimum \$475 fine and a point added to their driving record.

Family Resource Network – Executive Director Family Resource Network, a long standing 501(c) 3 is seeking a full-time Executive Director. FRN provides support, information, resources and referrals to families raising children with special needs and agencies. The incumbent will be responsible for fiscal management, program oversight, grant writing, and personnel administration. The Executive advises and is responsible to the Board of Directors.

Candidates should hold a minimum of a Bachelor's Degree in Public Administration, Social Work or a related field. However, any combination of education and successful experience providing the required skill and knowledge for success will be considered. The candidate should have successful experience writing grants, excellent organization and management skills and be computer literate. Previous community involvement in the field of special needs is a plus, as well as previous experience working with a non-profit and collaborative experience working with other agencies.

This is a full time, Exempt position which requires some travel in San Joaquin and surrounding counties. The monthly salary is subject to education, past work experience and knowledge in the field of special needs. Benefits include sick and vacation pay. A stipend to help defray the cost of health insurance will be offered. The applicant will be subject to background checks including Live Scan Fingerprinting, Child Abuse Index Check, Credit Check and Reference Checking and drug testing. Proof of ability to work in the United States required.
