



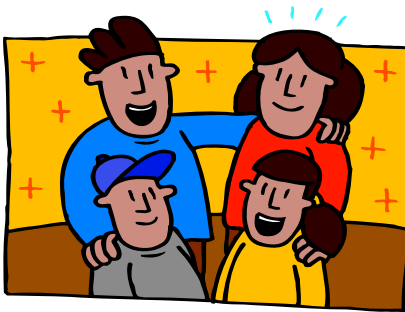

There are 4 workshops in the Saturday series and parents are asked to commit to attending all sessions. **Sessions will be conducted Saturdays, January 8th through 29, 2011, at FRN's Stockton office from 9 a.m. to noon.**

16th Annual Early Start Symposium

What Makes You Smile?

Tuesday, November 2, 2010 marks the date for the 16th Annual Early Start Symposium. Paul Glassman, DDS, M.A., MBA, from the University of the Pacific's School of Dentistry will be a keynote presenter on a topic the Symposium has not presented before - "The Importance of Getting An Early Start on Good Oral Health." Dr. Glassman has years of experience serving the special needs community and he brings to the event a wealth of knowledge on the subject of oral health and the important role it plays in a child's early development.

We will have a second keynote presentation this year. Kris Faith and Katie Faith Lingo will share their very personal story of being twins - one of whom has Down syndrome. Parents and professionals alike will find their presentation informative and inspirational.

There will be breakout sessions in the afternoon on dental care associated with syndromes, bringing structure to home and social environments, using sign language to foster language development, addressing behavior issues, and ideas to help children with motor issues gain stability and move towards mobility.

Scholarships are available to parents living in Amador, Calaveras, San Joaquin, Stanislaus or Tuolumne Counties whose children are receiving Prevention Program or Early Start services. There are a limited number of scholarships for parents of preschoolers receiving special education services. 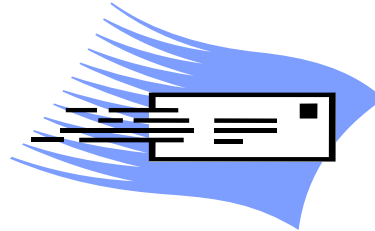

Reprinted from Special Education Rights and Responsibilities by CASE and DRC:

What happens to my child's special education program if we move from one school district to another?

When a pupil moves during a school year into a new school district that is not part of the same Special Education Local Plan Area (SELPA), the new school district must provide the student with a free appropriate public education, including services which are comparable to those in his previous district's IEP for the first 30 days of attendance in the new district. A SELPA is either a single large school district or a collection of school districts which constitutes a geographic region and which is organized to pool special education resources and to determine special education fund distributions to the various programs or school districts within the SELPA. During those first 30 days, the new district must either adopt the old IEP or develop, adopt, and implement a new IEP that is consistent with federal and state special education law. [Cal. Educ. Code Sec. 56325(a)(1).]

If a pupil moves to a new school district that is within the same SELPA, the new district must continue, without delay, to provide services comparable to that contained in the previous IEP, unless the parents and district develop, adopt and implement a new IEP which conforms to state and federal special education law. [Cal. Educ. Code Sec. 56325(a)(2).]

If a child transfers into California with an IEP from another state, his new school district must provide him with a free appropriate public education, including services comparable to those in his previous IEP, in consultation with his parents, until the new district conducts any new assessments determined to be necessary, and then develops a new IEP. [Cal. Educ. Code Sec. 56325(a)(3).] The child's new school district must take reasonable steps to promptly obtain the child's school records, and the child's previous school district must take reasonable steps to respond to the new school district's request for these records. [Cal. Educ. Code Sec. 56325(b)(1); 20 U.S.C. Sec. 1414(d)(2)(C)(ii).]

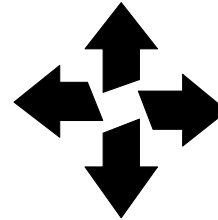
Financial and Estate Planning Workshop

IEP Checklist iPhone Application

Offered free of charge in both English and Spanish, this new IEP app helps parents of students with special needs become better informed advocates by keeping IEP information organized and making it easier to access. It displays 13 primary categories that relate directly to IEP meetings. Each category displays a quick reference guide of essential information and has room for a parent's own notes. Some comments on the application: “This is just the sort of tool that families that have children in special education need to prepare and participate in the IEP. It not only gives them the information on IDEA 2004 and the IEP but also assists in keeping their child's information organized and easily accessed.”

Community Advisory Committee for Special Education

CAC PURPOSE

The role of the CAC is to advise the School District's Board of Education about special education issues, to provide access to training and information and to work collaboratively with the school district to improve student outcomes.

The CAC participates in the development, amendment and review of the Local Plan for Special Education, and recommends annual priorities to be addressed by the plan. The Local Plan describes how services will be delivered to special education students in accordance with federal and state laws.

The California department of Education (CDE) divides the state into areas for the purposes of planning and monitoring how the special education services are delivered to students with disabilities. These areas are called Special Education Local Plan Areas (SELPA). CDE mandates that all SELPAs maintain a Community Advisory Committee for Special Education.

CAC MEMBERSHIP

The Community Advisory Committee for Special Education CAC membership is composed of volunteers, including parents of individuals with exceptional needs enrolled in public and private schools, parents of other students enrolled in school, pupils and adults with disabilities, general and special education teachers, other school district personnel, representatives of other public and private agencies, and others concerned with the needs of individuals with exceptional needs. Members are appointed by the Board of Education.

CAC PARTICIPATION

Any parent of a student in the district (public or private), staff or community member may attend and participate in CAC meetings. Ask questions, share concerns and have your voice be heard. If you have any ideas about how the CAC can help students with exceptional needs and promote parent and community involvement, please contact your local CAC.

Many CACs offer presentations on topics of interest as part of their CAC agenda. You can contact your local CAC to get a schedule of meetings for the school year or to find out how you can be added to the CAC's mail or email list.

What is Workability?

The Workability program provides comprehensive pre-employment skills training, employment placement and follow-up for high school students in special education who are making the transition from school to work, independent living and post secondary education or training.

Workability offers special education students the opportunity to complete their secondary education while also obtaining marketable job skills.

Workability program seeks employers in the business community who will give students with special needs a chance to prove themselves.

The WAI program is funded and administered by the CDE. Not all schools districts or SELPAs offer Workability. Some districts offer programs similar to Workability. Contact your district or SELPA for information on a work experience program in your area.
