Keynote Speaker – Nancy B. Robinson, Ph.D. CCC-SLP, Professor, Special Education and Communicative Disorders, San Francisco State University Topic: Using Assistive Technology to Encourage Social Interaction: From High Tech to Everyday Items, and Everything In Between

In addition to being a professor at San Francisco State University, Nancy Robinson has co-written a new book entitled *Assisted Technology for Young Children: Creating Inclusive Environments*. She has conducted workshops throughout the State identifying ways that parents and professionals can use assistive technology to enhance the lives of young children with special needs. She will identify high end technology options as well as how to use everyday items commonly found in households. In addition to the keynote, there will be breakout sessions on topics including language development, assistive technology, visual impairment, mobility/medically fragile and behavior/sensory integration.

Dear Early Start Supporters,



Early Start eligibility and federally-required services funding has been restored to pre-2009 levels! This will take effect starting January 1st, 2015. Now, much work needs to be done to educate our community about the restoration of Early Start. We need to spread the word in the community that starting January 1, 2015, infants at risk of a developmental disability, and toddlers between 2 and 3 years of age with delays of 33% in one developmental area, are once again eligible for Early Start's life-changing services.



Family Resource Network wishes to thank all those parents and professionals who wrote letters and signed petitions in favor of restoring Early Start. FRN staff is working with representatives from the Regional Center, School Districts/SELPAs and Prevention Resource and Referral Services to prepare for the changes in Early Start eligibility. Your advocacy effort on behalf of infants and toddlers with special needs is truly appreciated.

#### Community Advisory Committee for Special Education

#### CAC PURPOSE

The role of the CAC is to advise the School District's Board of Education about special education issues, to provide access to training and information and to work collaboratively with the school district to improve student outcomes.

The CAC participates in the development, amendment and review of the Local Plan for Special Education, and recommends annual priorities to be addressed by the plan. The Local Plan describes how services will be delivered to special education students in accordance with federal and state laws.

The California Department of Education (CDE) divides the state into areas for the purposes of planning and monitoring how the special education services are delivered to students with disabilities. These areas are called Special Education Local Plan Areas (SELPA). CDE mandates that all SELPAs maintain a Community Advisory Committee for Special Education.

#### CAC MEMBERSHIP

The Community Advisory Committee for Special Education CAC membership is composed of volunteers, including parents of individuals with exceptional needs enrolled in public and private schools, parents of other students enrolled in school, pupils and adults with disabilities, general and special education teachers, other school district personnel, representatives of other public and private agencies, and others concerned with the needs of individuals with exceptional needs. Members are appointed by the Board of Education.

#### **CAC PARTICIPATION**

Any parent of a student in the district (public or private), staff or community member may attend and participate in CAC meetings. Ask questions, share concerns and have your voice be heard. If you have any ideas about how the CAC can help students with exceptional needs and promote parent and community involvement, please contact your local CAC.

Many CACs offer presentations on topics of interest as part of their CAC agenda. You can contact your local CAC to get a schedule of meetings for the school year or to find out how you can be added to the CAC's mail or email list.

#### AUTISM THERAPY A MEDI-CAL BENEFIT

State officials said yesterday autism therapy clearly is a covered Medicaid benefit, and they hope to submit a state plan amendment by Sept. 30 to start the process to make it a Medi-Cal benefit for those under age 21.

According to René Mollow, deputy director of benefits and eligibility at the Department of Health Care Services, Medi-Cal children are entitled to applied behavior analysis -- known as ABA therapy.

"Right now we're working on the development of a state plan amendment. We want to engage the stakeholders in developing that," Mollow said. "We're looking to have it submitted at the end of September, and having it retroactive to July 1."

Medi-Cal children now receiving ABA therapy likely will have that care retroactively paid for by Medi-Cal.

The new policy should start by the beginning of next year, Mollow said. Till then, there is a lot to do to develop the provider network and reimbursement rates, she said.

"And the question is what to do in the interim, when people are looking to get services now," Mollow said.

Autism advocates were understandably delighted.

"We're thrilled that the state is moving in this direction, and very encouraged by the steps they're taking," said Kristin Jacobson, president of Autism Deserves Equal Coverage, an advocacy group based in Burlingame. "We want to work with them to implement this as expeditiously as possible."

### FRN Parent Scholarships Available

Family Resource Network has received an unrestricted grant of \$2,500 from the Stuart Foundation. FRN is using the funds to assist parents of special needs children within FRN's 5 county service area with registration fees to attend non-FRN conferences or workshops on topics related to children with special needs and their families.

#### New Publication: Equal Access to Extracurricular Activities for Students with Disabilities
